President's Report – Ralph Paulk: Ralph again expresses his gratitude for Tiretown being chosen Charity of the Year; talked about other companies wanting to acquire the Club and we, as members, need to think about what we can do for ourselves as a profitable non-profit; goal for 2025 would be to raise 100k; everyone needs to chip in somewhere.

Reiterates the need for VOLUNTEERS. Firestone Country Club needs volunteers for the APGA (African American event) scheduled for June 9th and 10th. Kids play the 8th. On Monday and Tuesday if we could get 10-12 members to come out and help, it would be greatly appreciated. Last year's volunteer numbers at Kaulig Championship were 36. Looking to increase that number to 80 this year.



