ARTICLE 111 (Objectives)

1. To create interest in and promote the game of golf.
2. To assume our civic responsibilities.
3. To assist, inspire and promote golf among our youth.
4. To sponsor and promote social activities.
5. To promote unity and camaraderie among its members.

ARTICLE IV (Membership)

1. Candidacy for membership is open to all people regardless of race, creed, gender or ethnicity after making proper application and payment of the joining fee \$50.00.
2. The election of a candidate for membership shall be by the members present at the designated meeting.
3. Associate members are allowed to participate in all social events and meetings but are non-voting members. Associate members have the option of becoming full members at any time during their membership. a) New Members \$50.00; b) Annual Renewal (less than age 70) \$125.00; c) Annual Renewal (ages 70-74) \$75.00; d) Annual Renewal (ages 75 and older) \$50.00
4. High school students upon proper application, payment of the joining fee (\$25.00) and signed approval from parent(s), shall be a candidate for Associate Membership. Associate membership terminates upon graduation and attainment of age 18.




