

TIRETOWN GOLF CLUB  
NOVEMBER 18, 2023, MINUTES

The meeting was called to order at 10:15 A.M. by Pres. Ralph Paulk.

October minutes were approved. The motion to accept them was made by B. Alford and seconded by T. Felton.

**President's Report:** Pres. Paulk gave thanks for the support given for the Scholarship Banquet and Jazzfest. Appreciation was also extended to PNC and Wayside for their support.

Treasurer's Report: Club balance is \$1719.80 and Charity balance is \$51,647.02.

The motion to accept the report was made by Dr. R Kaminski and seconded by F. Williams. The motion passed.

Secretary-Clarence Mitchell, Jr. nominated Glynis Mitchell. Marilyn Paulk withdrew from the position.

Financial Secretary-None, position closed.

Treasurer-None, position closed.

After the modified slate was accepted by the membership body. A single vote was cast electing the slate of nominees by Vice President M. Robinson, who was also chairman of the nominating committee.

Pres. Paulk thanked those (M. Robinson, L. Carney, R. Harris, and T. Dubose) who had previously served.

Pres. Paulk tasked every committee to present a proposed budget by December 15, 2023.

He also noted that 75K-80K was raised this year for the Charities and the goal is to spend more on marketing and scholarships.

Goals are many and it is most important to find funding.

The junior program must grow. PNC and Wayside have made commitments to support the program next year.

An annual report will be created for the Charities.

The Christmas party committee was given a budget of \$1000.00. M. Paulk has purchased gifts. The party will be held at the Alpha center on December 16th between 6 P.M and 10 P.M.

**Scholarship Committee** – D. Brown

- Continue to invite CLC kids.
- Feels there is a need to have reserved table signs at the banquet, which Miracle Trophies has created.

**Social Committee**- T. Dubose

Ted is stepping down after 20 years but will help.

**Golf Activities** – C. Mitchell, Jr.

- The pace of play has improved.
- First event is April 22, 2024, at Good Park
- Hosting the Ohio Cup this year and a committee has already been established.
- Not every club member will be able to play due to space limitations. A lottery may be needed.
- Club Championship August 24th and 31<sup>st</sup>.
- There will be a Friday event scheduled per month.

M. Paulk presented a financial report for the following:

- Total net profit - \$20, 505.56

J. Patterson collected donations for the banquet and Jazzfest. Dr. Kaminski obtained the MOJO Band and member S. Davis discounted the costs of his band, JUSFRIENZ.
